



# PHOTOCOPYING REQUEST FORM

## FOR PRIVATE STUDY / NON-COMMERCIAL RESEARCH

Photocopies for **non-commercial use** can be completed by, and at the discretion of, Library staff. The charge is 25p per A4 sheet (should A3 copies be required, they will be provided at 50p per sheet). There is a minimum charge of £2.00 to cover administrative costs. Photocopies will not be provided from original drawings, manuscripts, books published before 1800, or from large or fragile works. The declaration must be signed and the form returned with payment in advance of photocopying. It will usually be completed within one week and may be either held for collection or posted at no extra charge.

If you are unsure whether the copy you are requesting is for a non-commercial purpose, we would direct you to the British Library's website ([www.bl.uk/services/information/copyright.html](http://www.bl.uk/services/information/copyright.html)), and/or the Copyright Licensing Agency's website ([www.cla.co.uk/](http://www.cla.co.uk/)) for clarification, before signing this form.
