

## Segregate and other genera

The genus *Narcissus* was determined and named by Linnaeus in 1753. A number of segregate genera (listed below) were recognized and named by later botanists, notably R.A. Salisbury (1761-1829) and A.H. Haworth (1768-1833). However, the segregate genera are now regarded as synonyms of the genus *Narcissus* and are disused. It has been considered appropriate to revert to the single genus *Narcissus*.

The following segregate genera appear in synonymy.

The Register mentions one other genus apart from *Narcissus* or any of the segregate genera above: *Carregnoa* Boissier (1842). This was the genus in which Pérez Lara (1882) placed the taxon named *dubia* that was later treated as a synonym of *Narcissus* × *perezlarae* by Font Quer (1927).

Not mentioned in the Register, but the genus in which another author placed *Carregnoa dubia*, was *Tapeinanthus* Herbert (1837). This is now treated as a section within the genus *Narcissus*.
