Agenda Item 4d – Election of ordinary members to Council

The Council of the RHS is responsible for the strategic direction of the Society and ensures that it acts in accordance with the objectives set out in the RHS Charter. Council comprises the President, Treasurer, 15 ordinary members and up to two co-opted members. Those who serve on Council are also the trustees of the Society.

Every year, as part of the democratic running of the Society, at least three ordinary members of Council retire and the resulting vacancies are filled by election at the AGM.

At this year's AGM, Mick Crawley, Peter Gregory and David Rae will retire as ordinary members of Council. Their places will be filled by election for a term of five years.

Mick Crawley and David Rae are eligible to stand for re-election, Janet Walker has also been nominated and is eligible to stand for election. There are therefore three validly nominated candidates for three vacancies. Accordingly, Mick Crawley, David Rae and Janet Walker will be declared elected unopposed as members of Council.

Prof. Mick Crawley

Mick Crawley is Emeritus Professor of Plant Ecology at Imperial College London, where his research is focussed on the interaction between plants and their herbivores. His work was recognised by election to the Royal Society of London in 2002. He has twice been a Trustee of the Royal Botanic Gardens Kew, and was the Independent Member of the Joint Nature Conservation Committee.

He was the Royal Society Representative on Chelsea Physic Garden 2003-16. He has been a Trustee of the Botanical Society of Britain and Ireland since 2013 and a Council Member of the Royal Horticultural Society since 2015 (where he is a member of the Science Committee, Woody Plant Committee and Bursary Committee). In horticulture, he has been a garden designer in Ascot, he is Narcissus referee for BSBI and he has developed an extensive arboretum at Silwood Park, Berkshire, specialising in rare Quercus, Acer, Betula and Carpinus.

I am a professional horticulturalist and my last full-time post was Director of Horticulture and Learning at the Royal Botanic Garden Edinburgh. I am now the part-time Director of the Stanley Smith (UK) Horticultural Trust. I believe strongly in partnership working and international capacity building and in these capacities I have been the Chairman of PlantNetwork, the plant collections network of Britain and Ireland, the UK representative on the European Botanic Gardens Consortium and have initiated capacity building projects for botanic gardens in Bhutan, Turkey and Oman. I now serve on the boards of five botanic gardens and horticulture-related trusts. At home I am an enthusiastic gardener and my garden has been open to the public.

I Chair the RHS Bursaries, Science and Awards Committees and sit on the Horticulture Board.
