Additional fees for Section One Qualifications:

Late Entries (Theory Qualifications only)

RHS Qualifications publishes annually, on the centre timetable, the closing dates of entry for each examination for the following year. Entries submitted after the published closing date will be subject to a late entry fee. The total fee charged for late entries is twice the standard examination fee for each unit.

Any entries received after the final entry date will incur an additional £10 administration fee per unit.

Late Access Arrangements (Theory Qualifications only)

RHS Qualifications publishes annually the closing dates for access arrangements for each examination for the following year.

Access arrangement requests submitted after the published closing date will be subject to a £10 late fee per candidate.

Enquiry About Results (Theory Qualifications only)

The fee for re-mark and feedback by an RHS Examiner for any unit is £45 and £60 per unit, depending on the service available. This service is only available for the theory qualifications. Note that if a re-mark results in an upgrade of the result, the fee paid will be refunded.

Replacement Certificate (if lost, damaged or destroyed)

The fee for a replacement is £25, including postage and packing.

Independent Appeal

If a candidate wishes to take his or her result to independent appeal after following all previous processes of the RHS Qualifications Appeals procedure, a fee of £200 is payable to start the independent appeals process. If the appeal is successful the fee will be refunded.

Additional Centre Support Visits

Where a centre is required to undergo an additional visit by the RHS External Verifier in relation to action plans or performance issues, a fee of £200 plus expenses will be levied.

All fees are payable prior to confirmation of service or entry for the examination.

Any fees paid by candidates from outside the UK should be paid in pounds sterling and any bank charges are for the account of the candidate.

Fees are per candidate. Both registration **and** assessment & certification fees are paid upfront when the candidate starts their qualification; Centres are required to register **all** candidates on the RHS portal at the start of their course.

Notes:

- The learner registration fee is a one-off fee covering RHS administration of the learner's details on each qualification.
- The learner assessment and certification fee includes the 'standard' assessment of each learner and subsequent provision of certification. NB: additional fees will be incurred where a learner has to re-sit any element of the qualification assessment.
- 'Standard assessment' is a paper exam for theory units and an online/in person assessment for the practical certificate.
- Additional fees will be charged for the Level 2 and Level 3 Theory where centres / learners seek online assessment rather than paper-based examinations.
- Centres will not have to bear the cost of assessment themselves (in assessing or internally verifying the Level 2 or Level 3 Practical Qualification etc.) as these are now borne by the RHS.
- There are no minimum number of learner registrations on the qualifications. However, examiner visits for the Level 2/Level 3 Practical will require minimum numbers of learners to form a group to be assessed on each visit.

Notes:

[1] This fee applies to both theory and practical. Centres are required to register all candidates on their registration cohorts on the portal within 30 days of the start of their course, as stated in your planned provision. Registrations made after this date will incur this late fee.

[2] This applies to Unit 1 and Unit 2 exams. Please see the centre timetable for the closing date for registrations, after this date the late fee applies. **Important:** please see the centre timetable for the final date for registrations, we cannot accept any registrations after this date.

[3] This applies to PCAs. The closing date for registrations for PCAs is 6 weeks before the PCA date, after this time the late fee applies. After this date we cannot accept any registrations or changes to existing registrations.

[4] The OCA is an online assessment. Please see the centre timetable for the closing date for registrations, after this date the late fee applies. **Important:** please see the centre timetable for the final date for registrations; we cannot accept any registrations after this date.

[5] If centres have candidates taking the theory exams (Unit 1 and Unit 2) as an online exam at home, with remote invigilation, there is an additional fee.

[6] If centres have candidates taking the theory exams (Unit 1 and Unit 2) as an online exam at the centre, with invigilation by centre staff, there is an additional fee.

[7] This is the fee for candidates resitting a theory exam (Unit 1 and Unit 2); please register them on the exam cohort at the next exam session, please see the portal for examination dates.

[8] This is the fee for a candidate to resit the Level 2 and Level 3 PCA Plant Identification task; this can be done online either at home with remote invigilation, or at the centre (if offered by the centre) which is invigilated by centre staff.

[9] This is the fee for a candidate to resit all 3 PCA tasks (not including the plant identification), at the regional Resit days organised by RHS.

[10] This is the fee for a candidate to resit all 3 PCA tasks (not including the plant identification) at their Centre, if they do not wish to attend the regional centre.

[11] These are the fees to resit the Level 2 and Level 3 OCA online assessment; this can be done online either at home with remote invigilation or at the centre (if offered by the centre), which is invigilated by centre staff.

[12] The deadline for centres to submit OCA access arrangement applications is stated on the Centre Timetable; the deadline for PCA access arrangement applications is 6 weeks before the PCA date (this is the same as candidate registrations and groupings for the PCA day). This fee will be charged if applications are submitted after these dates, and applications will be accepted in exceptional circumstances only.

[13] This fee will be applied where a centre requests that a candidate changes PCA date/group, after the 6 week registration and groupings deadline. Such changes will be considered a late registration.

[14] RHS Qualifications publishes annually the closing dates for access arrangements for each Theory examination for the following year. Access arrangement requests submitted after the published closing date will be subject to a £10 late fee per candidate.

[15] This fee will be applied where a centre requests that a candidate changes from Online exams to Paper exams, and vice versa (whether this is Online at Home or Online at Centre) after the relevant registration deadline. Such changes will be considered a late registration.
