Conditions of Entry

- Please be aware we are a garden therefore we ask exhibitors to take their waste home with them and encourage you to recycle if possible.
- Please note all Rosemoor Food Fairs are intended to sell either snack items, produce to take home and cook with, or products to improve cooking at home. We have award-winning onsite caterers selling a range of food and meals to eat on the day.
- Whilst every effort is made to try to balance out those products on sale we cannot guarantee that there will not be several other stall holders offering similar products for sale.
- **Stall Allocation:** Stalls will be allocated taking into account the nature of the product on offer and the general layout of the venue and once such allocation has been made, no changes will be permitted.
- Stands: Exhibitors should provide their own tables and chairs where possible. A *limited* number of tables and chairs are available from Rosemoor and need to be booked in advance. Exhibitors should also provide their own table coverings. Excess stock should be stored safely under your tables, or in your vehicles.
- Electricity: Electricity up to 500W is available in The Garden Room if required and will be charged at £15 incl VAT per socket. Please contact us if you require a power supply for larger appliances. Please note it is a legal requirement that all electrical equipment used must be PAT tested (Portable Appliance Tested) and be maintained in accordance with IEE regulations and the requirements of the Electricity at Work Regulations. Rosemoor staff will be doing on the day checks
- Build up and Breakdown: The Garden Room will be available for setting up the day before the Chilli Fiesta from 1pm 4.00pm and on the first morning of the Fair from 8.00am. We ask that all stands be set up by 10.00am, when The Garden Room will open to the public. Exhibitors and stalls should not be closed before 4.00pm on each day.
- Security and Insurance: Whilst every possible care will be taken over security, the RHS cannot be held responsible for any loss, damage or theft. Exhibitors should arrange their own insurance if required. Please note it is a condition of entry that all Exhibitors must have their own Public Liability Insurance cover for a minimum of £2 million. A copy of your insurance certificate must be submitted with your booking form.
- Cancellation: In the event of cancellation by the stallholder up to two months before the first day of the fiesta, 50% of the stand fee will be returned. Thereafter, no refunds will be given.
- Parking: Overnight parking may be permissible, but strictly by prior arrangement and at owner's risk.
- All our events are aimed to add value to a visitor's day and to increase membership
 recruitment therefore normal Garden Entry charges will apply to members of the public,
 although RHS Members and their guests will have free entry, as always. No separate
 admission charge will be made for entry into any part of the Fiesta and all of the activities will
 be included.
