

Terms & Conditions for RHS Gardens Prize Draw to win a £250 RHS Gift Card

- The Royal Horticultural Society with registered charity numbers 222879/SC038262 of 80 Vincent Square, London, SW1P 2PE (the **RHS**) is the promoter of the prize draw.
- 2. The prize draw is open to all UK residents aged 18 years or over, except employees of the RHS, their families, agents or any third party directly associated with the administration of the prize draw.
- The prize draw is free to enter, and no purchase is necessary. There is a limit of one entry per person. Entries on behalf of another person and joint submissions are not permitted.

 - 4.1scanning the QR code on the RHS prize draw card (given out on entry to a RHS Garden) which will take applicants to the RHS Sign Up Form on the RHS website: or
 - 4.2directly filling out the RHS Sign Up Form on the RHS website.
- 5. The prize draw runs from 12.01am on 12 May 2025 (the **Opening Date**) until 11.59pm on 11 May 2026 (the **Closing Date**). Entries received after this time will not be valid.
- A winner will be selected every quarter until the Closing Date by a random draw performed by a computer process.
 - The winner will receive a £250 RHS Gift Card which can be redeemed at all RHS retail shops and garden centres.

- The winner will be notified by email or phone (using the details provided at entry). If the winner does not respond to the RHS within 5 working days of being notified by the RHS, then the winner's prize will be forfeited. The RHS may select another winner following the process described above.
